Subject: Regarding issuance of no objection certificate to ST. MARY'S SCHOOL
(ENGLISH MEDIUM) NAI BAZAR, BUXAR for affiliation with CISCE Board, New Delhi

Sir,
Regarding the above mentioned subject, a competent committee of the department has reviewed the affidavits taken before the Executive Magistrate and enclosed documents which were made available by the Principal/ Secretary/ School Management, for the granting of no objection certificate to St. Mary School English Medium, Nai Bazar, Buxar for CISCE affiliation.

According to that the condition of the school was found as follows:

1. The school is run under the SHAHABAD PARISH SOCIETY. This society is not under control by any one person or family. The details of each member of society/trust and affidavit has also been given.
2. The school management has claimed that it doesn't use any other registered Trust /Society/ Trust/ Franchise of any Trust or brand name of any school.
3. The school has 2 Acres and 07 Decimals of land available. The school has its own building and library and laboratory is also available. The CISCE board will have to inspect the site to ensure that the infrastructure and all other facilities of the school are in conformity with the board's standard or not. The committee has not inspected the site and verified the correctness of the documents of these institutions. In this regard, the department has done the review on the basis of records and affidavits submitted by the school.
4. A total of 21 teachers are appointed in the school. The CISCE New Delhi will have to ensure that the appointment of teachers, their qualifications and training is in accordance with the norms of the National Council for Teacher Education.
5. The school has claimed that Hindi is a compulsory subject being taught.
6. The school has assured to make it public the fees structure, annual audit report, annual report every year. CISCE New Delhi may ensure that the school acts according to the assurance given by them.
7. It has been agreed by the school through written affidavit that it accepts the requisite conditions mentioned in the no. Application No. 238 dated 04/04/2006 by the Department:-

According to requisite conditions:

(i) Free enrollment of 25 percent of the total capacity in the school will be done for the children of the family living in the neighborhood and they will not be charged tuition fee or any other type of fee. In the category of such children, Scheduled Castes, Scheduled Tribes, Backward Classes, Extremely Backward Classes, Minority, Disabled Girls and general category families, whose annual income will be less than Rs 2,00,000 (two lakhs) per year are included.

(ii) No admission test or interview (including children and parents) will be taken for admission in nursery / KG or primary class in the school. If application for admission is more than the prescribed capacity, then children will be selected for admission through open mode (lottery).

(iii) Children seeking admission for nursery / KG and primary classes will have a maximum distance of one kilometer from their home to school and maximum distance of three kilometers for admission in upper primary and secondary classes.

(iv) Arrangements will be made to return 80 percent of the application fee charged from the children whose admission is not confirmed.

8. It will be mandatory to fulfill all the criteria related to RTE. CISCE will ensure compliance to the concerned while giving affiliation to private schools.

9. Even though the school management has claimed through affidavit regarding the fulfilling of all the mandatory conditions, CISCE New Delhi should check from its level to ensure that the school is run on the basis of the criteria set by them.

10. CISCE, New Delhi has to ensure that the mandatory and requisite conditions are being followed by the concerned school as per their consent. The school has to make this conditions public and it should be mentioned in the Prospectus and website. In case of violation of the terms, no objection certificate will be withdrawn and action will be taken to cancel the affiliation.

11. The schools will have to follow orders regarding not giving corporal punishment to the students by the teachers, according to the departmental letter no.46 Dated 18.01.2008.

12. The school will remain open at any time for inspection by the inspecting officer of the Education Department or Health Department of the Government of Bihar.

As per the decision taken by the departmental committee in the light of the above mentioned conditions, no objection certificate for affiliation with CISCE, New Delhi is granted to ST. MARY'S SCHOOL (ENGLISH MEDIUM), NAI BAZAR, BUXAR with the condition that CISCE New Delhi will consider giving affiliation only after satisfied with its side.
